

THIS AGREEMENT is made the 1st day of March 2008

BETWEEN: Legal Aid Ontario
(hereinafter called "LAO")

AND: Law Foundation of Ontario
(hereinafter called "LFO")

AND: HDR Corporation
(hereinafter called the "Revenue Forecaster")

1. SCOPE OF WORK

The Revenue Forecaster will develop a revenue forecast model for predicting interest on lawyers' trust accounts (IOLTA) that quantifies risk and uncertainty. The model will have the following characteristics:

- Provide both annual and three year forecasts;
- The model needs to be easy to use and update;
- The model must be simple to explain; and,
- The model may ultimately be quarterly, BUT must be capable of producing monthly revenue estimates.

In addition, the Revenue Forecaster will provide input on economic data including:

- Contrasting real estate data sources; and,
- Identifying sources of economic forecasts.

1.1 DELIVERABLES

As project deliverables, the revenue forecaster will provide a Draft Final Report and a Draft executable MS Excel Forecasting Model to both LAO and LFO. These deliverables will be finalized based on LAO and LFO input.

2. FEES/PAYMENTS

2.1 The term of this Agreement will be from May 5, 2008 to June 13, 2008.

- 2.2 LAO and LFO agree to pay the Revenue Forecaster, by remittance to HDR Corporation at 1545 Carling Avenue, Suite 410, Ottawa, ON K1Z 8P9, \$35,000, the cost to be shared equally between LAO and LFO, for the Scope of Work listed above.
- 2.3 The Goods and Services Tax (GST) is not included in the above fees. It will be shown clearly as a separate item on the invoices. LAO and LFO will be responsible for the payment of all GST and other applicable governmental fees and taxes.
- 2.4 Separate invoices in the amount of \$12,250 (excluding taxes) will be sent to both LAO and LFO after delivery of the Draft Final Report and Model. The balance of \$10,500 (excluding taxes) will be invoiced to LAO and LFO in equal amounts of \$5,250 (excluding taxes) after LAO and LFO acceptance of these deliverables.

3. INSURANCE

- 3.1 The Revenue Forecaster shall provide insurance to protect itself from claims under workman's compensation acts; from claims for damages because of bodily injury, including personal injury, sickness, disease, or death or any employees or of any other person; from claims from injury to or destruction of property including loss of use resulting therefrom; and from damage to or destruction of property including valuable papers and records coverage and including loss resulting therefrom.

4. TERMS AND CONDITIONS

- 4.1 The attached Terms and Conditions for Professional Services are made a part of this Agreement and are incorporated by reference.
