

THIS AGREEMENT made as of January 14, 2008

BETWEEN

Daphne FitzGerald and Terrie Russell of "BOARDrx Inc."
(hereinafter referred to as "BOARDrx")

AND

LEGAL AID ONTARIO
(hereinafter referred to as "LAO")

WHEREAS:

- A. In 2008 LAO is launching a province-wide performance measurement initiative across all programs and departments, to be supported by foundation training in logic models;
- B. BOARDrx is a consulting firm with expertise in performance measurement and has extensive experience with LAO and the clinic system.

NOW THEREFORE in consideration of the mutual covenants, promises, and undertakings contained herein, the parties agree as follows:

1. BOARDrx shall consult with Sherry Cameron-Stobie, Director of Quality Service Office, and Susanne Hunter, Staff Lawyer, QSO, to determine LAO's needs, and develop a one day training session in logic models to ensure organisational readiness for the project.
2. BOARDrx shall deliver one day of training by a mutually agreed upon date to be no later than March 4 2008.
3. BOARDrx shall provide permission to have the training recorded and produced on DVD format for province-wide training of LAO staff. BOARDrx shall be acknowledged as holding copyright.
4. LAO shall pay \$600 per day for consultation, preparation and delivery of training session, due to BOARDrx within thirty (30) days after receipt of an invoice satisfactory to LAO and receipt by LAO of the final product.

5. LAO may retain BOARDrx at the same rate of \$600 per day for ongoing advice relating to the development of LAO's logic model at suitable intervals, to seek external advice on the developed model.
6. BOARDrx shall not assign, transfer or pledge this Agreement or retain subcontractors for the performance of her obligations hereunder without the prior written consent of LAO. No assignment or subcontract shall relieve BOARDrx from his obligations under this Agreement or impose any liability upon LAO to any assignee or subcontractor.
7. This Agreement is a contract for a particular project and shall have no power or authority to bind LAO or to assume or create any obligation or responsibility, expressed or implied, on LAO's behalf.

This Agreement shall be interpreted in accordance with the laws of the Province of Ontario, and the laws of Canada.
