Dear

Thank you for your *Freedom of Information (FOI)* request for access to information, which our office received on August 10, 2012. You have requested information regarding "93 cases of suspected fraudulent overbilling since 2007".

Since Section 90(1) of the Legal Aid Services Act applies to the information you have requested, the information is not subject to disclosure under the Freedom of Information and Protection of Privacy Act (FIPPA). Further, exemptions may be claimed pursuant to FIPPA, were Section 90 not to apply in this case.

However, I am authorized to tell you that, while Legal Aid Ontario investigates overbilling by lawyers and pursues recovery of overbilled amounts, Legal Aid Ontario does not maintain records which distinguish between cases of fraudulent overbilling, versus suspected fraudulent overbilling, versus negligent overbilling, versus inadvertent overbilling. Therefore, there are no records responsive to your request for information about cases of "suspected fraudulent overbilling". I can confirm there were two cases in the period 2007 to present in which Legal Aid Ontario made a referral to police for possible charges to be laid in connection with overbilling. In those cases, a total of \$125,000 was overbilled and \$112,500 was recovered. There were no legal costs associated with recovering those funds.

Legal Aid Ontario takes very seriously its obligation to ensure public funds are mangaged appropriately. Legal Aid Ontario is also committed to transparency and public access to information within the limits of its governing legislation. In that spirit, Legal Aid Ontario publishes information on its website which is of interest to the public. Information relevant to your request will be available in the future on Legal Aid Ontario's website, at www.legalaid.on.ca. I trust you will find this information helpful.
