CLCYR is seeking an experienced housing lawyer to lead and continue to strengthen our eight-person Housing Team. The proposed start date for this position is as soon as possible. The salary for this position is up to \$120,000.00, (based on 84% of LAO Grid plus \$5,000 stipend).

## **Qualifications Include:**

- Passion for securing justice for low-income and vulnerable residents of York Region by seeking to enforce and uphold the housing laws which are supposed to protect them;
- Membership in good standing with the Law Society of Ontario;
- At least six years legal practice, preferably in housing law;
- Excellent oral and written advocacy skills including extensive experience appearing before administrative tribunals, along with court experience;
- Excellent knowledge of Ontario's tenant protection laws;
- Excellent knowledge of administrative law and relevant constitutional and human rights laws;
- Experience in, and passion for, public advocacy and law reform lobbying;
- Demonstrated knowledge of social justice principles and understanding of issues of significance to low-income communities;
- Understanding of anti-racism and social justice and how to apply this understanding in the practice of law;
- Experience in trauma-informed service provision;
- Legal clinic experience is an asset;
- Ability to provide legal services to Franco-Ontarians is an asset;

• Ability to speak a second language is an asset;

- Reporting to the Director of Legal Services, the Housing Team Lead is the leader of a team of lawyers and licensed paralegals. You inspire them to aggressively and energetically apply their legal expertise to minimize residential evictions in York Region;

- Mentoring and overseeing staff to ensure that they are providing expert and savvy legal representation and advice that best secures our clients' homes;
- Participating in the development and implementation of strategies and tactics for law reform lobbying and public advocacy to best protect the homes of our client community;
- Working with community partners to ensure that maximal housing supports are available to our client community;
- Providing representation in important test cases;
- Collaborating with your fellow Team Leads and our management team to facilitate the optimal day-to-day operation or our organization;
