
## **Expert Rates**

LAO is taking the following steps as of April 1, 2011 to address the bar's concerns regarding the difficulty in retaining experts under current hourly rates.

- 1. Hourly rates for LAO funded-experts will be increased. The new expert rates will
  - apply to designated experts in all legal aid areas, including BCM/CCR, PCU, standard criminal, family, refugee and civil cases.
  - be paid on all post-April 1<sup>st</sup> certificates and on pre-April 1<sup>st</sup> certificates if the expert has not already been authorized by LAO.

The experts affected by this increase and the new hourly rates are outlined in the chart below:

### Expert rates: current vs. new rate



- Additional funding will be allocated for experts retained in BCM or CCR (Complex Case Rate) matters.
  - Counsel on BCM/CCR cases may apply to LAO for additional expert funding over and above the April 1 increase to hourly expert rates.
  - The additional funding will be used to "top up" hourly expert rates in circumstances

where there is a need to retain an expert from outside Ontario, for example.

- The process for additional funding for an expert will be based on LAO procurement policies; applying lawyers may be asked to provide quotes to support a request for additional expert funding.
- Over time, LAO will develop expert "vendors of record" to streamline the process for securing experts in BCM/CCR matters and to support the bar
- The approval process for additional expert funding for BCM/CCR matters will be the same as that currently followed in setting BCM/CCR budgets. More information on this process will be available soon.

# **Billing Gladue**

LAO's portal billing page for criminal accounts is currently configured to require you to select "charges heard separately" to submit an account with a Gladue matter, even if there is only one charge. Rather than selecting an additional 'charge', the system needs to be reprogrammed to create a Gladue enhancer. LAO is taking steps to secure the IT resources needed to make this change.
