## **2 The Rules are amended by adding the following after section 12:**

### **Financial eligibility for duty counsel services**

**12.1** (1) Despite subsection 12(1), this section applies in respect of an application for duty counsel services made during the period commencing March 3, 2025 and ending March 3, 2028.

(2) An individual is financially eligible to receive the legal aid services referred to in subsection (1) or to continue receiving those services if

- (a) the income of the individual's family unit, less any support reduction or medical reduction, does not exceed the maximum income set out in the Table for duty counsel services for a family unit that matches the individual's family unit in number; and
- (b) the value of the liquid assets of the individual's family unit does not exceed the maximum value of liquid assets set out in the Table for duty counsel services.

**3 The Rules are amended by adding the following after section 12.1:**

**Financial eligibility for certificate services in a criminal matter**

**12.2** (1) Despite subsection 12(1), this section applies in respect of an application for certificate services in a criminal matter made during the period commencing March 31, 2025 and ending March 31, 2028.

(2) An individual is financially eligible to receive the legal aid services referred to in subsection (1) or to continue receiving those services if

- (a) the income of the individual's family unit, less any support reduction or medical reduction, does not exceed the maximum income set out in the Table for certificate services in a criminal matter for a family unit that matches the individual's family unit in number; and
- (b) the value of the liquid assets of the individual's family unit does not exceed the maximum value of liquid assets set out in the Table for certificate services in a criminal matter.
