3 additional hours for Ministerial Intervention or Exclusion

(available on certificates issued on or after October 16, 2023)

3 additional hours for representation before the RPD where the Minister has intervened or where the Minister or a member has formally raised exclusion (in writing).

Required attachments:

- None – lawyers may be required to provide Minister’s notice of intervention or proof of exclusion having been raised upon audit.

3 additional hours where a Designated Representative has been appointed for an Adult Claimant or an Unaccompanied/Separated Minor

(available on certificates issued on or after October 16, 2023)

3 additional hours for representation before the RPD where the applicants are unaccompanied or separated minors; or where the applicants are adults with serious mental health concerns and/or cannot appreciate the nature of the proceedings.

Required attachments:

- None – lawyers may be required to provide proof of DR appointment upon audit.

2 additional hours for preparation for a Subsequent Attendance at an RPD hearing

2 additional hours for the subsequent attendance following a hearing which proceeded but did not conclude on:

(complete date)

Note: The 2-hour “subsequent attendance” authorization should not be requested or billed for an attendance where the matter did not proceed and was postponed/adjourned.

Required attachments:

- None – lawyers may be required to provide Notices to Appear and proof a hearing proceeded upon audit.

2 additional hours for Written Submissions

2 additional hours for preparation of written submissions following an otherwise concluded hearing.

Required attachments:

- None – lawyers may be required to provide a copy of written submissions upon audit.
