Overview of LAO travel authorizations

LAO will consider travel authorization requests in accordance with sections 46 (1), (2), and Schedule 2 of the Legal Aid Services Rules, in keeping with the Legal Aid Services Act, 2020:

- Travel time may be payable for travel of more than 50 kilometres, one-way, from the acknowledging roster member's regular place of business.
- Requests must be submitted within 30 days of acknowledging the certificate or within 30 days
 of a material change in circumstances beyond the roster member's control that results in travel
 being required. Requests submitted after 30 days may be refused.
- Requests for travel authorization within the Greater Toronto Area will not be considered.

Travel authorization decisions are made prudently, with the intention of maintaining the integrity of the local bar, especially in rural, remote and underserved areas. Legal Aid Ontario may consider the following factors when assessing requests for travel authorization on a certificate:

- Lack of local counsel to conduct the case in the jurisdiction of the trial. If local counsel is unavailable, clients should first seek lawyers from neighbouring jurisdictions before looking further afield.
- Geographic limitations on the availability of a lawyer.
- Availability of counsel with sufficient expertise on the nature of the case and evidence to be presented.
- The acknowledging lawyer has a prior client/solicitor relationship with the client.
- The client is on a contributory certificate.
- The client has unique needs that local counsel are unable to meet.
- Ability to meet the requirements of the French Language Services Act.
- Whether a reasonable client of modest means would incur the additional travel expense of retaining out-of-town counsel
